

- 3. The TWG shall have the following responsibilities and functions:
 - a. Develop, review and finalize the Implementing Rules and Regulations to further guide the establishment of the Sports High School and High School for the Arts;
 - b. Develop, review and finalize the Development Plans to provide clear frameworks for the operations, programs, and services of the 2 schools;
 - c. Consult with DepEd Central and Regional Offices and relevant external stakeholders on the provision of guidance and technical support in the finalization of the IRR and Development Plans; and
 - d. Submit finalized IRRs and Development Plans within set timelines.
