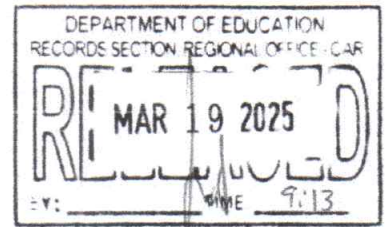

**REGIONAL ORIENTATIONS ON CLIMATE CHANGE AND BATANG
 EMERGENCY RESILIENT TEAM (BERT)**

To: Schools Division Superintendents
 Heads, Public Elementary and Secondary Schools

1. Climate change and global warming are urgent global concerns. Their negative effects such as but not limited to hotter temperature, rising sea levels, heavy rainfall, stronger typhoons, and flooding greatly impact our rights to life, education, food, water and sanitation. Raising climate change awareness among school personnel and learners and equipping them with the knowledge to prepare for its negative effects are crucial in addressing this global crisis in the school level.

2. The DepEd-CAR through the Education Support Services Division will conduct an orientation on Climate Change and an orientation on Batang Emergency Resilient Team (BERT) on April 1 and 2, 2024, respectively at the Hotel Tugos, Naguilian Road, Baguio City.

3. The Climate Change orientation aims to conduct awareness on climate change and its effect on the basic human rights, and to strengthen school programs and activities on climate change adaptation and mitigation. A subsequent activity will be curriculum integration of Climate Change Adaptation and Mitigation concepts in coordination with the Curriculum Learning Management Division (CLMD). The BERT orientation will focus on strengthening student awareness, participation and conduct of preparedness and mitigation activities. Enclosed is the program of activities for reference.
