The Civil Service Commission Cordillera Administrative Region (CSC CAR) announces the face-to-face conduct of the *Supervisory Development Course Track 1* at *Banaue*, *Ifugao* on 27-30 May 2025.

The Supervisory Development Course Track 1 is a four-day **live-out** Learning and Development (L&D) program designed for government leaders, first-line supervisors, and aspiring leaders and supervisors.

Through this course, participants will be provided with the necessary insights to become effective supervisors capable of coping with stress and organizational challenges vis-à-vis the new paradigms in supervision and management. This course also serves as an enabling tool towards understanding one's self and career, handling responsibilities, becoming better leaders, enhancing stress management capabilities and learning essential communication process.




