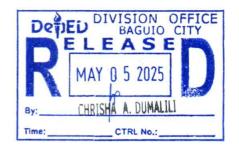

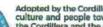

- 3. The Gawad KALASAG (KAlamidad at Sakuna LAbanan, SAriling Galing ang Kaligtasan) Search remains to be one of the country's fully institutionalized programs that encourages wider participation in promoting disaster risk reduction and management and climate change adaptation as indispensable requirements toward sustainable development.

- 5. In this regard, the undersigned is pleased to inform you that the Cordillera Regional Validation and Selection Committee is now accepting submissions for this year's Gawad KALASAG Seal and Special Awards for Excellence in DRRM and Humanitarian Assistance.
- 6. For the GK Seal LDRRMCO category, the deadline for submission of LDRRMCO self-assessment results using the prescribed toolkit, complete means of verification, and notarized Omnibus Sworn Statement is 5:00 PM, June 2, 2025. Kindly refer to Annex A for the Submission Procedures.

Likewise, interested applicants for the Gawad KALASAG Special Awards categories may submit their entries in ONE (1) HARD COPY and ONE (1) SOFT COPY (preferably in PDF format) following the prescribed style and format on or before 5:00 PM, May 23, 2025. Gawad KALASAG Seal for Local DRRM Councils and Offices Procedures in the Submission of Self-Assessment Results

Date Issued: 28 April 2025

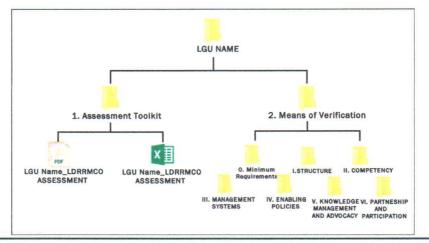
- In line with the submission for the Gawad KALASAG Seal for Local Disaster Risk Reduction and Management Councils and Offices (LDRRMCOs) category, all LDRRMCOs shall submit their self-assessment results along with:
 - a) Accomplished LDRRMCO Assessment Toolkit
 - b) Minimum Requirements folder
 - c) Means of Verification folder
 - d) Notarized Omnibus Sworn Statement
- 2. The following are the procedures for the submission:
 - a) Ensure to label the folders and documents according to their respective criteria, preferably with short text/title only.

FOR LGU SELF-ASSESSMENT

- Create a folder specifically for the LDRRMC&O ASSESSMENT.
- Save a copy of this file on the created folder and rename file as follows: LGU Name LDRRMCO ASSESSMENT.
- Click the LGU Information icon and accomplish the necessary details.
- Perform an honest appraisal of your LDRRMC&O based on the attached/presented MOVs through a self-assessment rating using the prescribed Checklist for LDRRMC&O Assessment
- Save the file. Click the Summary of Assessment icon and click Save Results as PDF located at bottom right part of the sheet.

Note: All means of verifications (MOVs) shall be attached / uploaded in a folder and shall be labeled according to their respective criteria.

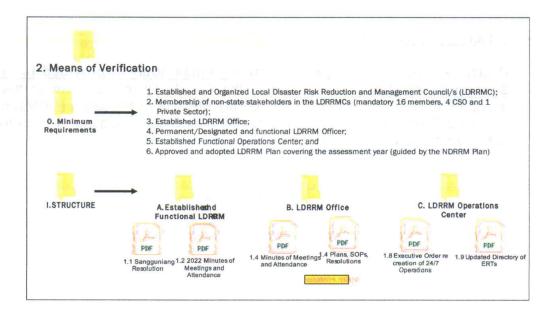

- b) Attachment of Pictures. All pictures must be in colored format; at least two (2) photo attachments are required and supplemented with text description or should not exceed to three (3) photos when not accompanied with text description. HD photos are required in order not to compromise the quality when expanded or otherwise.
- c) Presentation of Compliance. The presentation of compliance in different criteria should be clear, concise, and straight to the point; it is highly encouraged to provide the whole document of a specific MOV but avoid unnecessary inclusion in the folder.
 - Submit whole document the with the appropriate approved resolutions/memorandum of plans (e.g., local DRRM plan, CPs, CLUP, CDP, SOPs,
- d) Fill-out the LGU Submission Form that can be found through this link below. Make sure that the respondent has already logged in using an existing Google Mail (Gmail) account before accessing this link.

e) Manner of Submission. The self-assessment results (accomplished Toolkit in excel and PDF formats) with the Means of Verification (MOVs) and notarized omnibus sworn statement can either be submitted through a flash drive or uploaded in the designated Google Drive folder of the LGUs, or can also be both.

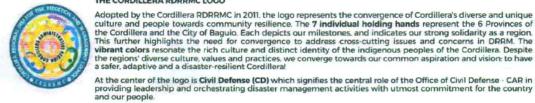

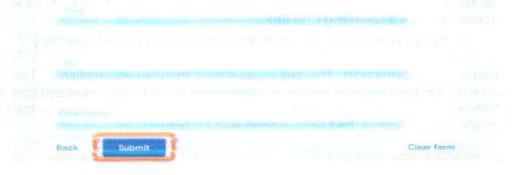
Option 2: Google Drive

Please be reminded that <u>only the official email address provided to the GK Secretariat will be given access</u> to the Google Drive folder where the Self-assessment Results (accomplished Toolkit), Means of Verification (MOVs) can be uploaded. Using a different email address may need to request access to your designated Google Drive folder.



Upon completion of the Submission Form (see previous page), the form will direct the respondent to the LGU's designated Google Drive folder. Copy the link first and paste to a blank document or open a new tab in your browser. Submit and upload the folder containing the Accomplished Toolkit (PDF and Excel File) and Means of Verification (MOVs) in the respective Google Drive folder per LGU. Ensure that the documents uploaded are final and complete.

Go back to the Google form and make sure to click the **Submit** button to fully complete your submission.



IMPORTANT REMINDERS

- a) If your area is experiencing unstable internet connection, avoid uploading the whole folder at once. Uploading each folder based on the criteria may be done to prevent errors and failure.
- b) Access to each LGU folder will be restricted once documents after the deadline.

ANNEX B

Gawad KALASAG Special Awards

Style Guide for Entries

- This style guide applies only for entries for the following categories: Hospitals, Schools, Civil Society Organization (CSO), Volunteer Organization, Peoples' Organization, Private Organization, Government Emergency Management and Response Teams (GEMs), and Special Recognition for Individuals and Organizations.
- 2. All entries must contain an accurate Table of Contents, indicating the Preliminaries and Criteria including their corresponding pages. All pages except the Table of Contents must indicate their corresponding page numbers. Each criterion shall be tabbed accordingly. Please see attached sample.
- 3. Introduction shall be limited to the following:
 - a. Brief description or profile of the category
 - b. Brief message and acknowledgments
 - c. Executive Summary
- 4. All pictures must be colored and in high-definition quality to ensure clarity when expanded. There shall be a minimum of two (2) photo attachments per page if supplemented with captions, or at least three (3) photos when not accompanied with captions.
- 5. A minimum of two (2) scanned copies of documents per page is required. Unless of utmost importance or relevance that the contents may not be readable when reduced in size, such documents shall be allowed to occupy an entire page.
- 6. All entries shall be submitted book bound and hardbound in one single document. Consideration shall be made for localities wherein hard binding services are not available. In such case, the OCD Regional Office concerned shall furnish the Gawad KALASAG Secretariat a certification, signed by the Regional Director, to prove the same.
- 7. The following standards on font type, font size, paper size, paper orientation, line spacing, indents, and the maximum number of pages shall be required for all entries.
 - a. Font type: Times New Roman/Arial
 - b. Font size for the context: 12
 - c. Paper orientation: Portrait
 - d. Paper size: A4
 - e. Line spacing: Single spacing

- f. Indents provided for in the style guide sample format
- g. Maximum pages: <u>300</u> including introduction, annexes, and attachments (NOT back-to-back)
- 8. The following color coding of entry cover page according to category shall be followed:

Hospitals: Blue

Schools: Green

Civil Society Organization: Yellow

· Peoples' Organization: Orange

Volunteer Organization: Violet

· Private Organization: Pink

 Government Emergency Management and Response Teams (GEMs): Red

Special Recognition and Heroic Act: White

- 9. The presentation of compliance in different categories shall be clear, concise, and straight to the point. Unnecessary inclusion whether in text or document to an entry is highly discouraged. Annexes shall be limited to the following:
 - a. Means of verification
 - b. Relevant photos
 - c. Clearances/ Titles
 - d. Minutes of the Meeting
 - e. MOA/MOU
 - f. Documents that will prove a claim

To facilitate efficient and orderly deliberation and evaluation of all entries, deliberate non-compliance to the aforementioned requirements shall merit disqualification of the entry.
