This contract made and entered into by and between:

DEPARTMENT OF EDUCATION - SCHOOLS DIVISION OF BAGUIO CITY, with office address at # 82 Military Cut Off, Baguio city and herein represented by its Schools Division Superintendent, SORAYA T. FACULO, Phd, CESO VI, hereinafter referred to as the "CLIENT."

CHALET BAGUIO, with principal address at #42 CM Recto St., Corner Leonardwood Rd., Baguio City, represented herein by its authorized representative Samuel M. Carantes III, hereinafter referred to as the "CATERING COMPANY."

WITNESSETH

WHEREAS, the Client will conduct "QUARTERLY CID MONITORING, EVALUATION AND ADJUSTMENT" on March 24, 2025, June 23, 2025, September 22, 2025 and November 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is SIXTY SEVEN THOUSAND TWO HUNDRED PESOS ONLY (Php 67,200000.00)

WHEREAS, 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003', allows an agency to resort to Small Value Procurement as an alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (phP 1,000,000.00) as prescribed in Annex "H"thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and agency website on March 3, 2025 to March 10, 2025.

WHEREAS, three suppliers submitted their RFQs who are as follows:

- 1. FOOD SERVICES DEPED CANTEEN;
- 2. CHALET BAGUIO; and,
- 3. OLIVE HOTEL;

WHEREAS, after review and deliberation, CATERING COMPANY complied with the requirements and declared as the Lowest Calculated and Responsive Bidder (LCRB);

WHEREAS, the Client is desirous that the Catering company execute the Meals and Snacks for the Conduct of Quarterly CID Monitoring, Evaluation and Adjustments on March 24, June 23, September 22 and November 2025 and has accepted the quotation for Sixty Seven Thousand Two Hundred Pesos Only (PhP 67,200.00) by the Catering Company for the execution and delivery of service.

1. Place, Location and Date

The **Catering Company** shall provide food (AM Snacks, Lunch, PM Snacks-House Specialties) to the participants of the **Quarterly CID Monitoring, Evaluation and Adjustments** on March 24, June 23, September 22 and November 2025.

2. Number of Participants

The total number of participants are twenty eight (28).

3. Responsibilities

The **Catering Company** warrants to provide **AM Snack**, **Lunch**, **PM Snack** on March 24, June 23, September 22 and November 2025 pursuant with the submitted proposed menu during post qualification.

4. Liability

The **Catering Company** shall be held responsible for damages if the menu provided during post-qualification cannot be fulfilled.

The **Catering Company** shall be liable for an additional thirty percent (30%) in damages if the items are not delivered according with the provided specifications within the contract period specified in this agreement.

5. Termination of Contract

The **Client** may terminate this Contract base on the grounds provided and after compliance with Annex "I" of the 2016 Implementing Rules and Regulations of Republic Act 9184.

6. Term of Contract

This Contract shall be effective on March 24, June 23, September 22 and November 2025.




