The *Department of Education, Schools Division of Baguio City* through the **Program Support Fund for School Based Feeding Programs** intends to apply the sum of **One Million Seven Hundred Fourteen Thousand Six Hundred Eighty Pesos Only (₱ 1,714,680.00)** being the ABC to payments under the contract for the **Procurement for the Provision of Sterilized Milk for SBFP Learner Beneficiaries to Be Given for 15 Days**.

The procurement of the project will be conducted through **Negotiated Procurement (Two Failed Biddings)**, an Alternative Method of Procurement, in accordance with the 2016 Revised Implementing Rules and Regulations of Republic Act No, 9184.

The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline to the BAC and which would meet the minimum technical specifications required.

The *Department of Education, Schools Division of Baguio City*, #82 Military Cut-Off **Baguio City** will hold a Negotiation Meeting on July 25, 2025 at 10:00 AM at the **Schools Division of Baguio City, Conference Hall**.

Your company is hereby invited to submit two (2) copies of the quotation/proposals (one original and one copy) in sealed envelopes, labeled as "**Negotiated Procurement for Two Failed Biddings- Procurement for the Provision of Sterilized Milk for SBFP Learner Beneficiaries to Be Given for 15 Days**" which must be duly received by the BAC Secretariat through manual submission at the Department of Education, Schools Division of Baguio City, #82 Military Cut Off, Baguio City on or before 10:00 am of **July 29, 2025**. The spare parts and other components required are listed in **Section VI (Schedule of Requirements)** and the costs thereof are included in the contract price.

The Supplier shall carry sufficient inventories to assure ex-stock supply of consumable spare parts or components for the Goods for a period *twenty four (24) months*.

Spare parts or components shall be supplied as promptly as possible, but in any case, within one (1) month of placing the order.

**Packaging –**

The Supplier shall provide such packaging of the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in this Contract. The packaging shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packaging case size and weights shall take into consideration, where appropriate, the remoteness of the Goods' final destination and the absence of heavy handling facilities at all points in transit.

The packaging, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly

provided for in the Contract, including additional requirements, if any, specified below, and in any subsequent instructions ordered by the Procuring Entity.
