





RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT – SMALL VALUE PROCUREMENT TO CHALET BAGUIO

WHEREAS the Department of Education prepared the Purchase Request (PR) for the Procurement of Meals and Snacks with Venue for the Upskilling and reskilling of teachers and non-teaching personnel on the conduct of IPED related research including RISE with an Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Pesos Only (₱120,000.00) (Annex A);
