

1. The Department of Education through the Bureau of Education Assessment, announces the Administration of the **2025 Regular Philippine Educational Placement Test (PEPT) on February 15, 2026**, at Manuel L. Quezon Elementary School, Baguio City.
2. All qualified registrants shall receive a confirmation message from the Division Testing Coordinator on or before February 6, 2026.
3. Examinees are required to bring the following during the testing day:
 - a. Two (2) lead pencils (No. 1 or No. 2)
 - b. Eraser
 - c. Sharpener
 - d. Clean sheet of paper
 - e. School ID or any valid ID for verification purposes
 - f. Meals and Snacks
4. Examinees are required to be at the testing venue not later than 6:30 am on the testing day, February 15, 2026.
5. Testing personnel are required to be at the testing venue not later than 6:00 am on the testing day.
6. Parents and guardians are allowed only in designated areas when bringing and fetching their child/ward to the testing venue. In no case that parents or guardians will accompany their children/ward in the testing room.
