RESOLUTION NO. 01 S. 2026

RECOMMENDING THE AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO CASALDO LYNDON BACMOR SECURITY AGENCY
FOR THE PROCUREMENT OF SCHOOL SECURITY SERVICES FOR 2026

WHEREAS Don Mariano Marcos Elementary School prepared the Purchase Request (PR) for the Procurement of school security services for 2026 with an Approved Budget for the Contract (ABC) of One Hundred Ninety Nine Thousand Nine Hundred Fifty Pesos Only (₱199,950.00);

WHEREAS on 12/1/2025, the school's – Bids and Awards Committee (BAC) prepared the Request for Quotation (RFQ) for the said procurement project and requested at least three (3) price quotations from different suppliers. The following suppliers signified their intent to participate by submitting their respective quotations/proposals, to wit:



WHEREAS the proposal of CASALDO LYNDON BACMOR SECURITY AGENCY is found to have the Lowest Calculated Responsive Bid (LCRB) with its price quotation amounting to One hundred Ninety Nine Thousand Nine Hundred Fifty Pesos Only (₱199,950.00).

WHEREAS Section 34.3 (g) of R.A. 12009 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity (HoPE) in favor of the supplier, contractor, or consultant with the LCRB, MEARB, MARB or HRRB. In case of approval, the HoPE shall immediately enter into contract with the said supplier, consultant.




