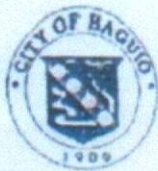
**CALL FOR APPLICANTS FOR THE GAWAD LINGAP PROGRAM (GLP)

1. Pursuant to City Ordinance Numbered 59 Series of 2024 "Amending the provisions of Ordinance Numbered 07, s. 2022 [an ordinance institutionalizing the Gawad Lingap Program (GLP) in the City of Baguio for Public Elementary and Secondary Students and providing funds hereof]. The Schools Division of Baguio City announces the call for Public and Private Kinder to Grade 12 indigent learner-applicants.
2. Gawad Lingap Program aims to assist Baguio City indigent learners who need financial assistance to support their daily expenses in school.
3. Submission of documentary requirements for Public School applicants shall be made to their respective School Gawad Lingap Focal Persons, while Private School applicants shall submit their requirements directly to the Division Office- Youth Formation Unit through Arlani B. Buccat. The submission period shall commence on **June 15, 2026** and shall end on **August 14, 2026**. School-prescreened applications shall be submitted to the Schools Division Office of Baguio City – SGOD Youth Formation on or before **August 18, 2026** only. Documents submitted beyond the prescribed deadline shall no longer be entertained.

**EXECUTIVE ORDER NO. 95, SERIES OF 2022.**

**IMPLEMENTING RULES AND REGULATIONS OF CITY OF BAGUIO  
ORDINANCE NUMBERED 07 (SERIES OF 2022) OR  
AN ORDINANCE INSTITUTIONALIZING  
THE GAWAD LINGAP PROGRAM (GLP)  
IN THE CITY OF BAGUIO FOR  
PUBLIC ELEMENTARY AND SECONDARY STUDENTS,  
AND PROVIDING FUNDS HEREOF**

To effectively implement the provisions of COB Numbered 07 (Series of 2022), the Office of the City Mayor, following Section 12 of the above-named Ordinance, and pursuant to the powers vested in therein, hereby issues, adopts and promulgates the following rules and regulations.

**RULE I:**

**TITLE, DECLARATION OF POLICY, OBJECTIVES, AND APPLICATION**

**Section 1. Title.** This shall be known as the Implementing Rules and Regulations (IRR) of "Baguio City *Gawad Lingap* Program of 2021".

**Section 2. Declaration of Policy.** It is the policy of the City Government of Baguio to make education accessible and affordable to all – Education for All (EFA). With this policy, no student shall be forced to drop-out from school due to financial constraints. Also, it is the vision of the City Government to drastically reduce incidents of students in the elementary and secondary levels dropping out from school and missing out on education opportunities.

**Section 3. Objectives.** This program generally aims to address the issues that arose from the Citizens Satisfaction Index Survey (2017) for education services of the Department of Education. Specifically, it aims to assist Baguio City learners who are in need of financial assistance to support their daily expenses in school.

**Section 4. Application.** This IRR shall apply to students enrolled in any public elementary or secondary schools in the City of Baguio.

**RULE II:**

**QUALIFICATIONS AND GUIDELINES OF SCHOLARS**

**Section 5. Qualifications Scholars.** In order to ensure equal and equitable access to the benefits provided by the Program, scholars must have the following qualifications:

- a. Must be enrolled for the ensuing Academic Year in any public school within the Schools Division of Baguio City;
- b. Must belong to families certified as indigent by the City Social Welfare and Development Office;
- c. Applicants must not have an existing stipend and/or scholarship grant from any agency, company and/or individual, regardless of the amount being received, at the time of their application;

- d. Applicants must not have intention to enroll in schools outside Baguio City; and
  - e. The joint annual income of scholars' parents, parent, or legal guardian, as the case may be, must not exceed ONE HUNDRED FIFTY THOUSAND PESOS (PhP150,000.00).

**Section 6. Guidelines for qualified scholars.** Qualified scholars, if accepted into the program, shall be guided by the following criteria in order to remain as program beneficiaries, to wit:

- a. The student must not incur absences equivalent to 5% of the total school days per academic year;
- b. Must have passing remarks in all subjects in every grading period;
- c. Must be actively involved in curricular and co-curricular activities of DepEd and the City Government of Baguio; and
- d. Qualified applicants who wish to transfer schools in another School Division will be automatically removed from the roll of beneficiaries.

### RULE III:

#### DOCUMENTARY REQUIREMENTS, PROCEDURES, PROGRAM MONITORING AND EVALUATION

**Section 7. Documentary Requirements.** Applicants together with their parents and/or guardians shall secure the following documentary requirements to be considered in the screening process:

- a. Letter of Intent to apply for the program;
- b. Certification from the Office of the City Social Welfare and Development (OCSWDO), through their unit offices, that the applicant belongs to indigent family/household;
- c. Accomplished application form;
- d. Endorsement Letter from the School Head; and
- e. Essay prepared by the applicant, narrating the family's background, which may be in the vernacular language most preferred by the applicant.

**Section 8. Procedures.** The determination of short list of qualified scholars considered as beneficiaries of the program shall under the screening process as codified under the matrix attached here as Annex "A", to wit:

#### 1. Screening

**Step 1.** Letter of intent and application will be pre-evaluated by the School Principal



where the student is enrolled, before endorsing the same to the Gawad Lingap Committee;

**Step 2.** Assessment/ evaluation of documents submitted will done for short listing;

**Step 3.** Posting short list of possible grantees;

**Step 4.** Applicants will be scheduled for interview together with their parents and/or guardian;

**Step 5.** Deliberation of the Gawad Lingap Committee; and thereafter

**Step 6.** Announcement of qualified students

2. **Awarding.** Awarding of qualified students will be notified through their respective school principals, and thereafter be required to attend an orientation program that coincides with the execution of Contract;
3. **Annual monitoring.** The students' performance throughout the academic year shall be monitored by the Youth Formation Coordinator. The students' parents/guardian shall request a copy of the child's monthly attendance report from the school, and forward the same to the Youth Formation Officer.

**Section 9. Program Monitoring and Evaluation.** The grantee's evaluation and assessment shall be conducted at the end of every academic year.

#### **RULE IV:**

#### **CREATION AND COMPOSITION OF THE GAWAD LINGAP COMMITTEE**

**Section 10. Creation and composition of the Gawad Lingap Committee.** For the orderly and efficient implementation of the Program, specifically on the screening and awarding of financial assistance to eligible students, the Gawad Lingap Committee (GLP) is hereby created, and shall be composed of:

**Chairperson:** City Mayor

**Co-Chairpersons:** Schools Division Superintendent, Baguio City

**Secretariat:** Youth Formation Officer, Department of Education (DepEd), Baguio City

**Members:** School Governance and Operations Division-Chief  
Education Supervisor (SGOD-CES), DepEd Baguio City  
School Governance and Operations Division-Education Program  
Supervisor (SGOD-EPS), DepEd Baguio City  
Local Youth Development Officer, City Social Welfare and Development Office (CSWDO)



President, Federation of Parents and Teachers Associations  
(FPTA), Baguio City

**RULE V:  
FUNCTIONS OF THE GAWAD LINGAP COMMITTEE (GLC)**

**Section 11. Functions.** The Gawad Lingap Committee (GLC) shall perform the following functions to ensure the effective implementation of this Ordinance:

- a. Formulate policies and guidelines for the initial screening/award of the grant;
- b. Establish procedures and methods in the selection of recipients;
- c. Lead in the operation of the program from planning to execution;
- d. Draft guidelines and rubrics for recommending approval of applicants;
- e. Ensure the drafting and issuance of SDO, DepEd Baguio City Division Memorandum on matters of youth educational financial assistance;
- f. Accept, screen and interview applicants;
- g. Recommend to the Sangguniang Panlungsod for the increase of the grant being given to students;
- h. Identify and include other members in the Committee with the concurrence of all members;
- i. Provide final list of beneficiaries; and
- j. Hear and adjudicate on complaints and other issues regarding the program.

**Section 12. Appropriations.** Funds needed for its implementation shall be sourced from the General Fund of the Local Government of Baguio City under the Schools Division Office (SDO) with a total amount at least P2, 000,000.00 for every year and may be increased with the recommendation of the SDO thru the Gawad Lingap Committee. The amount shall be appropriated for the following:

Allowance per month (Secondary, Gr 7-12)	PHP1,000.00
Allowance per month (Elementary: K-Gr6)	PHP500.00
Total	PHP2,000,000.00



**RULE VI:  
FINAL PROVISIONS**

*Section 13. Separability Clause.* If any provision or section of this IRR, or the application thereof, is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

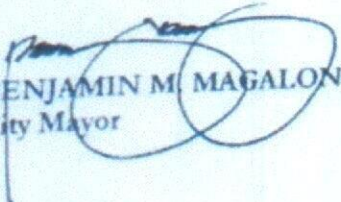
*Section 14. Amendment.* The Gawad Lingap Chairperson, through a majority vote, embodied in a Resolution to that effect, may amend a portion or portions of this IRR.

*Section 15. Repealing Clause.* All prior Executive Orders, Administrative Orders, Rules and Regulations, or part/s thereof that are inconsistent with the provisions of the IRR are hereby repealed or modified accordingly.

*Section 16. Effectivity Clause.* This IRR shall take effect in accordance with the provisions of Republic Act No. 7160, also known as the Local Government Code of 1991, as amended.

This Implementing Rules and Regulations (IRR) of City Ordinance Numbered 07, Series of 2022 otherwise known as *The Baguio City Gawad Lingap Program of 2021* is hereby approved by the undersigned, Chairperson of the Gawad Lingap Committee and City Mayor, Baguio City, Philippines.

**ORDINANCE Numbered 59**  
**(Series of 2024)**

AMENDING THE PROVISIONS OF ORDINANCE NUMBERED 07, SERIES OF 2022 [AN ORDINANCE INSTITUTIONALIZING THE GAWAD LINGAP PROGRAM (GLP) IN THE CITY OF BAGUIO FOR PUBLIC ELEMENTARY AND SECONDARY STUDENTS, AND PROVIDING FUNDS HEREOF].

**Explanatory Note**

The *Sangguniang Panlungsod* (City Council) of Baguio through Ordinance Numbered 07, Series of 2022 was able to extend its support through the *Gawad Lingap Program* (GLP) in the City of Baguio for public elementary and secondary students.

Expanding the provisions of the said Ordinance will further improve the support of the City and widen its coverage for efficient implementation.

NOW, THEREFORE, upon recommendation of the City Vice-Mayor, Hon. Olowan, and on motion of Hon. Mananeng, Hon. Cayabas, Hon. Fariñas and Hon. Edwin Jr., duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD (CITY COUNCIL) IN SESSION ASSEMBLED THAT:

SECTION 1. The title of Ordinance Numbered 07, Series of 2022 is hereby amended to read now as follows:

**"AN ORDINANCE INSTITUTIONALIZING THE GAWAD LINGAP PROGRAM (GLP) IN THE CITY OF BAGUIO FOR QUALIFIED KINDERGARTEN, ELEMENTARY, JUNIOR HIGH, SENIOR HIGH STUDENTS, DEFINING ITS PURPOSE, AND PROVIDING FUNDS HEREOF."**

SECTION 2. The provisions of Ordinance Numbered 07, Series of 2022 are hereby amended to read now as follows:

**"SECTION 1. TITLE. – This Ordinance shall be known as the "Baguio City Expanded Gawad Lingap Program".**

**"SECTION 2. DECLARATION OF POLICY. – It is the policy of the City Government of Baguio to make education accessible and affordable to all. It shall promote 'Education for All' so that no student shall be forced to drop out of school due to their family's financial constraints in line with the vision of the city government to reduce the drop-out cases among the public elementary and secondary students in the City of Baguio.**

"SECTION 3. OBJECTIVES. – This program generally aims to address the issues identified in the Citizens Satisfaction Index Survey (2017) under Education Services of the Department of Education. Specifically, it aims to assist Baguio City learners who are in need of financial assistance to support their daily expenses in school.

"SECTION 4. SCOPE AND APPLICATION. – The educational assistance program shall apply to residents of the City of Baguio and students who are officially enrolled in any basic education level composed of Kindergarten, Elementary School (Grades 1 to 6), Junior High School (Grades 7 to 10), and Senior High School (Grades 11 to 12) within the City of Baguio.

"SECTION 5. QUALIFICATIONS AND GUIDELINES OF SCHOLARS. – The qualifications necessary to comply with the program are the following:

- "1. Must be enrolled for the current School Year in any public or private school within the City of Baguio;
- "2. Must belong to indigent families;
- "3. Applicants must not have an existing stipend and/or scholarship grant from any agency, company and/or individual regardless of the amount being received; and
- "4. Joint annual income of parents must not exceed P150,000.00.

"The guidelines for qualified students are:

- "1. Qualified students must not incur five percent (5%) absences of the total number of school days;
- "2. Qualified students must have passing remarks in all subjects in every grading period;
- "3. Qualified students must be actively involved in all curricular and co-curricular activities of the Department of Education and the City Government of Baguio; and
- "4. Qualified students who wish to transfer schools to other divisions will be automatically removed from the roll.

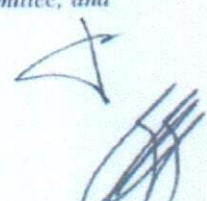
"SECTION 6. DOCUMENTARY REQUIREMENTS. – Applicants together with their parents and/or guardians shall secure the following documentary requirements to be considered in the screening process:

- "1. Letter of intent to apply for the program;
- "2. Certification from the City Social Welfare and Development Office (CSWDO) through unit offices that the applicant belongs to an indigent family;
- "3. Accomplished application form;
- "4. Endorsement letter from the School Head/Principal; and
- "5. Essay on the applicant's family background (applicants may use vernacular language).

"SECTION 7. PROCEDURES. – The identification of final scholars under this Ordinance shall undergo the following process:

"1. Screening

- "Step 1. Letter of intent and application will be pre-evaluated by the Head/Principal of the school where the student is enrolled before endorsing it to the Gawad Lingap Committee;
- "Step 2. Documents submitted will be assessed and evaluated for shortlisting;
- "Step 3. Posting a short list of possible grantees;
- "Step 4. Applicants will be scheduled for interview together with their parents and/or guardian;
- "Step 5. Deliberation of the Gawad Lingap Committee; and
- "Step 6. Announcement of qualified students.



"2. Awarding

"All qualified students will be notified through their school principals and are mandated to attend orientation on the program grant and signing of the contract.

"3. School Year Monitoring

"Students will be monitored by the Youth Formation Coordinator and will be instructed to submit monthly attendance reports.

"SECTION 8. PROGRAM MONITORING AND EVALUATION. – At the end of the school year, grantees will be undergoing evaluation to test the impact of the project on them. Selected grantees will also undergo focus group discussion to assess the program in relation to their daily schooling and to their motivation to continue and eventually finish their education.

"SECTION 9. CREATION AND COMPOSITION OF THE GAWAD LINGAP COMMITTEE. – In order to effectively implement this Ordinance specifically on the screening and awarding of financial assistance to eligible students, the Gawad Lingap Committee (GLC) is hereby created and composed of the following:

- Chairperson : - City Mayor
- Co-Chairperson : - Schools Division Superintendent, Baguio City
- Secretariat : - Youth Formation Officer, Department of Education (DepEd), Baguio City
- Members : - School Governance and Operations Division-  
Chief Education Supervisor (SGOD-CES),  
DepEd Baguio City
- School Governance and Operations Division-  
Education Program Supervisor (SGOD-EPS),  
DepEd Baguio City
- Local Youth Development Officer, City Social  
Welfare and Development Office (CSWDO)
- President, Federation of Parents and Teachers  
Associations (FPTA), Baguio City

"SECTION 10. FUNCTIONS OF THE GAWAD LINGAP COMMITTEE (GLC). – The Gawad Lingap Committee (GLC) shall perform the following functions to ensure the effective implementation of this Ordinance:

- "a. To formulate policies and guidelines for the initial screening/award of the grant;
- "b. To establish processes, procedures, and methods in the selection of qualified recipients;
- "c. To lead in the operation of the program from planning to execution;
- "d. To draft guidelines and rubrics for recommending approval of applicants;
- "e. To ensure the drafting and issuance of Schools Division Office, Department of Education, Baguio City Division Memorandum on matters of youth educational financial assistance;
- "f. To accept, screen, and interview applicants;
- "g. To make recommendations to the Sangguniang Panlungsod (City Council) of Baguio to ensure effective implementation of the program;
- "h. May identify and include other members in the Committee if essentially needed based on exigency with the concurrence of all members;
- "i. To provide the final list of beneficiaries; and
- "j. To hear and adjudicate complaints and other issues regarding the program.

"SECTION 11. APPROPRIATIONS. – This Ordinance shall be funded under the General Fund of the City Government of Baguio under the Schools Division Office (SDO) with a total amount of **₱5,300,000.00**. **The target number of beneficiaries per School Year is at least six hundred (600) with the following Matrix of Monthly allowances for ten (10) school months in one (1) year:**

<u>Grades 1 to 6:</u>	<u>P750.00</u>
<u>Junior High:</u>	<u>P1,000.00</u>
<u>Senior High:</u>	<u>P1,200.00</u>

**SECTION 11.a. While this program prioritizes those indigent students enrolled in public schools, but not totally exclude those equally qualified learners who are enrolled in private learning institutions. A maximum of 25% of the total number of grantees can be allocated to qualified learners enrolled in private schools within the City of Baguio.**

**SECTION 11.b. In order to accommodate more beneficiaries, a family can only avail one slot or one beneficiary per family.**

***SECTION 12. FORMULATION OF IMPLEMENTING RULES AND REGULATIONS. – The formulation of Implementing Rules and Regulations of this Ordinance shall be done by the Schools Division Office, Department of Education, Baguio City in close coordination with the Gawad Lingap Committee (GLC) in Section 9 hereof within thirty (30) days after its approval.***

***SECTION 13. SEPARABILITY CLAUSE. – If any provision or section of this Ordinance, or the application thereof to any person or circumstance is held invalid, the other provisions or sections of this Ordinance and the application of such circumstance shall not be affected thereby.***

***SECTION 14. REPEALING CLAUSE. – All prior Ordinances, Executive Orders, Administrative Orders, Rules and Regulations, or parts thereof that are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.***


***SECTION 15. EFFECTIVITY CLAUSE. – This Ordinance shall take effect in accordance with the provisions of Republic Act No. 7160, also known as the Local Government Code of 1991, as amended.***

SECTION 2. This Ordinance shall take effect in accordance with the provisions of Republic Act No. 7160, also known as the Local Government Code of 1991, as amended.

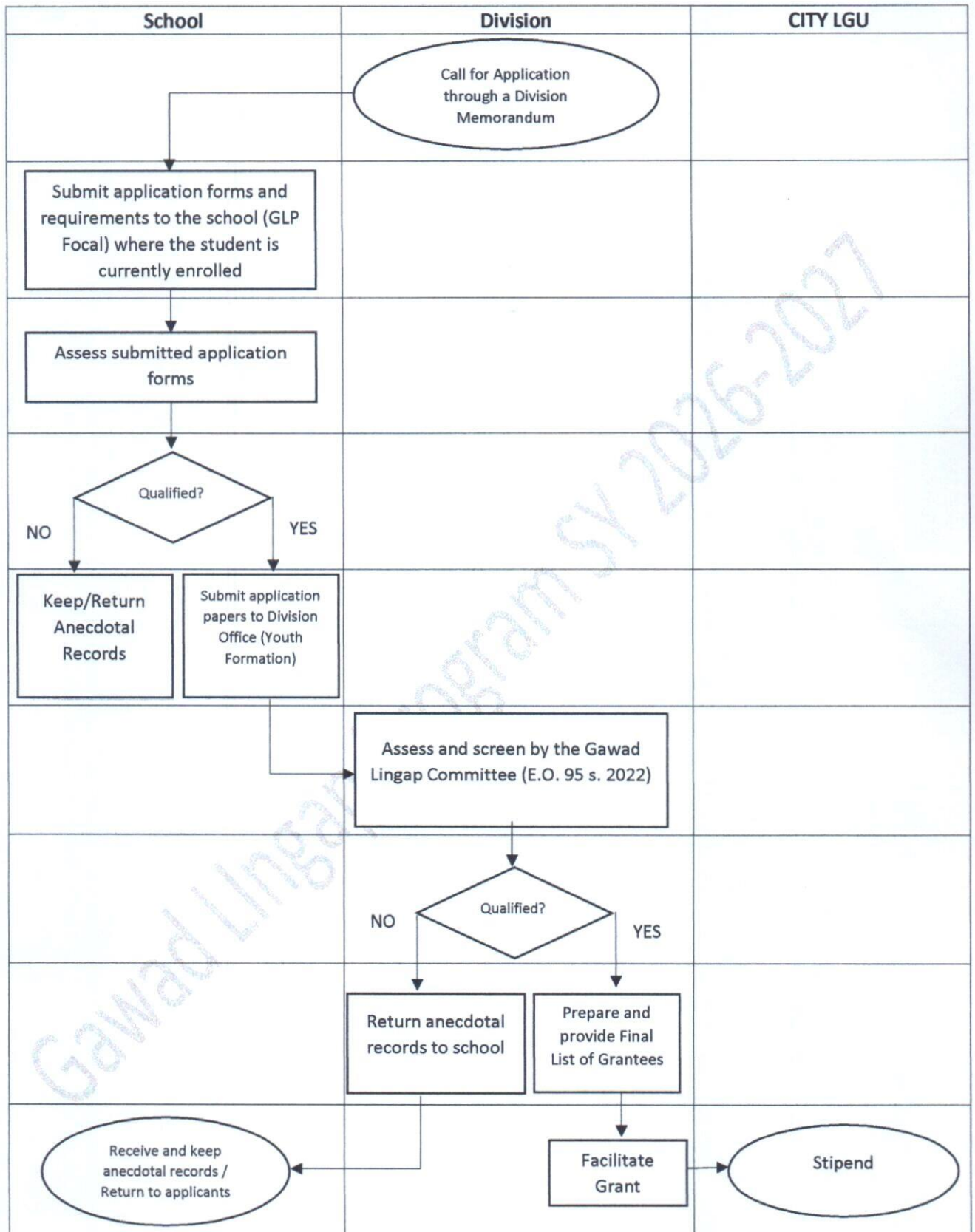
