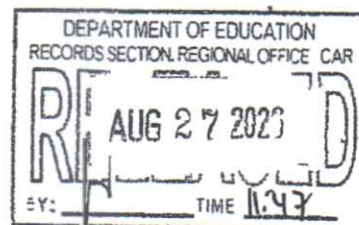

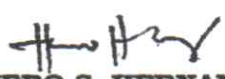

As part of this partnership, **One Santa LLP** is offering **free coding courses** designed to enhance learners' digital literacy, computational thinking, problem-solving, and programming skills. These learning opportunities are intended to complement existing DepEd programs and contribute to the development of future-ready learners.

In this regard, all Regional Offices are hereby **encouraged to disseminate this information to their respective Schools Division Offices and public schools** and to promote the availment of the free coding courses, subject to the implementation arrangements and guidelines provided under the Memorandum of Agreement. SDOs are encouraged to support schools that may express interest in participating in the program.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This **Memorandum of Agreement**, hereinafter referred to as the "Agreement," is entered into this 31 day of JAN 2025, 2024 at QUEZON CITY, Philippines, by and between:

The **DEPARTMENT OF EDUCATION**, hereinafter referred to as "**DepEd**," a government entity mandated by law to ensure the delivery of quality basic education, particularly **Batas Pambansa Blg. 232**, otherwise known as the "**Education Act of 1982**," as amended by **Republic Act No. 9155**, otherwise known as the "**Governance of Basic Education Act of 2001**," with principal address at **DepEd Complex, Meralco Ave., Pasig City, Philippines** represented by its Secretary, **JUAN EDGARDO M. ANGARA**;

-and-

The **ONE SANTA LLP** hereinafter referred to as "**OS**," a private entity T20LL1408B registered with the Singapore ACRA, Block 166 Yishun Ring Road #08-741, represented by its Founder, **GOO YI XIAN**;

Collectively referred to as "**Parties**," and individually as "**Party**."

WITNESSETH THAT:

WHEREAS, Article 14, Section 1 of the 1987 Constitution provides that "(t)he State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";

WHEREAS, the Department of Education is a government agency mandated to:

- (a) formulate, implement, and coordinate policies, plans, programmes; and projects in the areas of formal and non-formal basic education;
- (b) supervise all elementary and secondary education institutions, including alternative learning systems, both public and private; and
- (c) provide for the establishment and maintenance of a complete, adequate, and integrated system of basic education relevant to the goals of national development, while ensuring the well-being of its personnel and learners;

WHEREAS, DepEd, through the External Partnerships Service ("EPS"), believes that partnership is an important paradigm in delivering and achieving DepEd's education development goals and services and to fulfill the mandate of the Constitution to make such quality education accessible to all;

WHEREAS, DepEd has the responsibility of securing resources to make the public schools competitive and is now calling on the private sector to serve as a major partner for the improvement of the public education system and in the nation's development;

WHEREAS, Republic Act No. 8525 ("RA 8525"), otherwise known as the "Adopt-a-School Act of 1998," encourages external partnerships service to support the existing quality public education.

WHEREAS, Section 5 of RA 8525 provides that "provisions of existing laws to the contrary notwithstanding, expenses incurred by the adopting entity for the 'Adopt-A-School Programme' shall be allowed an additional deduction from the gross income equivalent to fifty percent (50%) of such expenses";

WHEREAS, the Department of Finance ("DOF"), through the Bureau of Internal Revenue ("BIR"), issued Revenue Regulations No. 10, s. 2003, entitled "Implementing Tax Incentives Provisions of Republic Act No. 8525, Otherwise Known as the 'Adopt-A-School Act of 1998'";

WHEREAS, DepEd shall comply with the applicable rules on the valuation of contributions or donations of private partners to DepEd and the proper recording of the donated items categorized as Property, Plant, and Equipment as contained in Item VII of the enclosure to DepEd Order No. (DO) 24, s. 2016 entitled "Guidelines on Accepting Donations and on Processing Applications for the Availment of Tax Incentives by Private Donor-Partners Supporting the K to 12 Programme," which provides the Valuation of Assistance/Contribution or Donation and the formula of computation for the value to be reflected in the Deed of Donation and the records of donated goods and services and DO 82, s. 2011 entitled "Guidelines on the Proper Recording of all Donated Properties";

WHEREAS, both Parties recognize and undertake to comply with the following laws, rules, and regulations:

- (a) RA 10173, otherwise known as the "Data Privacy Act of 2012," its Implementing Rules and Regulations, and other related issuances of the National Privacy Commission (NPC) and "Freedom of Information Order under Executive Order No. (EO) 2, s. 2016," for the implementation of this Agreement;
- (b) Joint Memorandum Circular No. 2010-01 issued by the Civil Service Commission and the Department of Health, DO 06, s. 2012 and DO 48, s. 2016 on DepEd's policy to not deal with the tobacco industry, or any individual or entity that works to further the interests of the tobacco industry, except to the extent strictly necessary to effectively regulate the tobacco industry and tobacco product;
- (c) DO 28, s. 2001 or "Prohibiting the Commercialization of the DECS Organization through Endorsements and Accreditation of Goods and Services" in the implementation of the programme, and DO 39, s. 2009 or "Strict Adherence to DO 28, s. 2001"; and
- (d) RA 9184, otherwise known as the "Government Procurement Reform Act" and its Implementing Rules and Regulations ("IRR"), and government accounting and auditing rules and regulations;

WHEREAS, OneSanta, an online learning platform from Singapore that strives to provide all students with quality, accessible and informative learning courses and materials, such as coding.

WHEREAS, OneSanta partnership with the Department of Education (DepEd) aims to offer all elementary school students with free access to online basic coding course. The objective is to provide students with the chance to learn the fundamentals of coding through a convenient and accessible online platform. By collaborating with DepEd, the organization seeks to ensure that the course is available to all elementary students, regardless of their location or financial background. The goal is to equip students with a strong foundation in coding and help prepare them for future opportunities in the field.

WHEREAS, this commitment refers to the dedication of OneSanta to collaborate with the Department of Education (DepEd) to guarantee that all students have both the opportunity and accessibility to develop their coding abilities. This involves supporting students in both traditional classroom settings within schools as well as through our online coding programme. The objective is to give students the necessary tools and resources to hone their coding skills and advance their knowledge in the field. By working together with DepEd, the organization aims to

make coding education accessible and inclusive for all elementary students.

NOW, THEREFORE, for and in consideration of the foregoing premises and the terms and conditions herein set forth, the Parties agree as follows:

Article I. ONESANTA SPONSORSHIP AND PROGRAMME SCOPE AND DELIMITATION

This partnership between OneSanta and the Department of Education (DepEd) aims to introduce a **Basic Coding Course** for elementary students in grades 4 to 6, across both public and private schools for free. The initiative seeks to broaden the scope of coding education beyond the standard curriculum, offering young learners an accessible and flexible opportunity to develop their coding skills.

Rationale for Targeting Grades 4 to 6:

Upon thorough discussions with the DepEd team, it was determined that students in grades 1 to 3 might face challenges in understanding coding due to their developmental stage and language comprehension abilities. Therefore, focusing on students in grades 4 to 6 ensures that the programme is both suitable and effective, aligning with their cognitive development and readiness to learn coding skills.

Course Accessibility and Delivery:

The Basic Coding Course will be delivered online, enabling students to learn from various locations, such as their homes or libraries, provided they have internet access. By offering this after-school activity, OneSanta ensures the course is accessible and convenient, allowing students to engage with the material at their own pace and on their own schedules. This flexibility supports diverse learning environments and accommodates the varying needs of students.

Course Content and Structure:

The coding course will cover three main topics:

1. Basic Scratch
2. Advanced Scratch
3. Introduction to Machine Learning

The curriculum includes five lesson videos and four quizzes, designed to help students gauge their understanding and progress. The course aims to impart essential coding and programming skills, including:

- Understanding the basics of coding: logic, structure, and sequence
- Manipulating data using programming languages
- Developing problem-solving skills.
- Learning how technologies communicate with each other

Educational Outcomes:

Upon completing the course, students will have a foundational understanding of computer science concepts and digital literacy. These skills are essential for solving complex real-world problems and serve as a foundation for future technological education and careers. This initiative not only equips students with valuable skills but also promotes innovation and enhances the overall quality of education.

Conclusion:

This partnership between OneSanta and DepEd represents a significant advancement in integrating essential 21st-century skills into the education system. By fostering collaboration between the private sector and the government, this initiative enhances educational opportunities and prepares students for future challenges, aiming to develop a generation of proficient problem solvers and innovators.

Article II. PROCEDURES AND BENEFICIARY

OneSanta, in partnership with the Department of Education (DepEd), is launching a nationwide Basic Coding Course for elementary students in grades 4 to 6, accessible to both public and private schools across the Philippines. This programme aims to provide free access to coding education, extending learning opportunities beyond the traditional curriculum and equipping young learners with essential digital skills.

Beneficiaries:

The programme will benefit public and private elementary students in grades 4 to 6 nationwide, offering them a valuable educational resource to enhance their coding abilities.

Methodology:

1. Partnership with DepEd:

- Collaborate with DepEd to secure support and endorsement for the coding course implementation.
- Ensure the programme is integrated into all public and private elementary schools for students in grades 4 to 6.

2. Parent Engagement:

- Guide parents through the process of signing up for an account on the OneSanta platform.
- Provide free access to the coding course materials upon registration.

3. School Implementation:

- Implement the coding course in all participating schools.
- Work closely with school administrators to encourage parental enrollment and student participation in the programme.

4. Lesson Access and Support:

- Offer clear guidelines to parents on how to access the lesson videos via the OneSanta website.
- Provide ongoing technical support to ensure smooth access and usage of the platform.

5. Evaluation and Measurement:

- Measure programme success through metrics such as student usage rates, course completion rates, and quiz scores for the three main topics.
- Use these metrics to continuously assess and improve the programme.

6. Equipment Requirements:

- Ensure students have access to mobile gadgets, tablets, iPads, laptops, or desktops with internet connectivity.
- Students will perform coding tasks using Scratch, which is best suited for desktops and laptops.

7. Duration:

- Each subscription will grant students one year of access to the lesson videos.
- This allows students to learn at their own pace, without interfering with their main curriculum.

Implementation Timeline:

- **October 2024:** Secure collaboration with DepEd by signing the MOA and developing detailed guidelines for DepEd, schools, and parents.
- **November 2024:** Begin school implementation, engaging schools and encouraging parents to sign up for the programme.
- **December 2024 to March 2025:** Monitor students' progress, provide necessary technical support, and evaluate programme effectiveness.
- **April to June 2025:** Collect project submissions, evaluate overall outcomes, and prepare recommendations for future iterations of the programme.

Article III. PROGRAMME COST

DepEd shall not shoulder any cost or expense relative to the conduct of this Pilot Programme.

Types of equipment needed for the implementation of the Basic Coding Course

1. Smartphones, iPads, Tablets and/or laptops/desktops with internet access are required to access the learning videos and quizzes from OneSanta, students
2. To code via the Scratch platform, it is recommended for students to access either via laptop or desktop.

Article IV. RIGHTS AND RESPONSIBILITIES

1. DepEd through the Curriculum and Teaching Strand shall:

- 1.1 Provide policy guidance and directions to ensure the proper implementation of the Programme;
- 1.2 Designate a focal person to serve as coordinator for this Agreement;
- 1.3 Assist in the evaluation of the implementation of the Programme;
- 1.4 Ensure the participation of all public and private elementary schools in this programme for students in grades 4 to 6;
- 1.5 Coordinate with OneSanta in the implementation of the Programme;
- 1.6 Perform other responsibilities necessary for the effective and efficient implementation of the Programme; and
- 1.7 Take the lead in the implementation of the Programme, selecting and endorsing participating schools to OneSanta.

1. OneSanta shall:

- 1.1 Designate a focal person to coordinate the implementation of this Agreement – Goo Yi Xian (yixian@onesanta.net) will be the focal person;
- 1.2 Provide the Programme for free to all identified learner beneficiaries stated in this Agreement;
- 1.3 Provide DepEd with regular reports, updates, as well as requested data and information relevant to the implementation of this Agreement;
- 1.4 Perform other responsibilities necessary for the effective and efficient implementation of the Programme;
- 1.5 OneSanta will be responsible for checking on the students participation rate based on lesson videos watched, quizzes scores attended and project coded;
- 1.6 OneSanta will update the relevant departments and personnel in-charges in accordance to the requirements needed;
- 1.7 OneSanta online helpdesk will be available for students and parents to clarify any technical issues; and
- 1.8 Completion rate will be recorded and submitted to the relevant departments at the end of the course term.

Article V. TERM AND TERMINATION

1. This Agreement shall be valid immediately effective upon signing of all Parties. This Agreement shall be in effect from the date of signing and shall continue to be valid and effective for two (2) years from such date, unless terminated by any party for any cause.
2. Any of the Parties may terminate this Agreement upon submission of a formal written notice to the other Party at least thirty (30) days before the intended date of termination. In case of material breach of this Agreement, the non-breaching Party may terminate or rescind this Agreement, without the need for legal or court action, within thirty (30) days upon notice to the breaching Party of such breach and the same remains unremedied.
3. Either Party may terminate the Agreement upon submission of a formal written notice to the other Party based on the following grounds:

- a. in case the government is put in an unfavorable or disadvantageous position;
- b. irreparable damage to the other Party;
- c. supervening impossibility or impracticability of performance due to force majeure or uncontrollable events (such as calamity, typhoon, earthquake, fire, etc.); and
- d. fraud, mistake, or misrepresentation

Article VI. CAPACITY AND AUTHORIZATION

Each of the Parties to this Agreement hereby represents and warrants to the other that it is duly authorized and empowered to execute, deliver, and perform this Agreement and that such action does not conflict with or violate any provision of law, regulation, policy, contract, deed of trust, or other instruments to which it is a party or by which it is bound and that this Agreement constitutes a valid and binding obligation of it enforceable in accordance with its terms.

Article VII. SEPARABILITY

In the event that any of the provisions of this Agreement or any document that may be executed in connection therewith shall be declared invalid, illegal, or unenforceable in any respect by a competent authority, the validity, legality, and enforceability of the remaining provisions of this Agreement or any document that may be executed in connection therewith shall not in any way be affected or impaired and shall remain in full force and effect.

Article VIII. LIABILITY AND INDEMNITY

The liability of the Parties for any breach of this Agreement shall be determined in accordance with applicable laws.

Article IX. BREACH OF AGREEMENT

Material violation or omission of any of the provisions of this Agreement shall be ground for termination or rescission of the same without the need for legal or court action.

Article X. FORCE MAJEURE

1. No Party shall be liable to the other Parties for any delay or failure to perform its obligations under this Agreement in case such delay or non-performance is due to any circumstance beyond the control of the affected Party, including but not limited to, acts of God, fire, explosion, earthquake, lightning, storm, volcanic activity hurricane, typhoon, perils of the sea, landslide, flood, drought, war, invasion, act of foreign enemies, riots, plague, epidemic, pandemic, damage or destruction by lightning, drought, heavy rains, or other natural disasters, or compliance with a mandatory order or request of the government including quarantine (in this Agreement, singly or collectively a "Force Majeure Event"), without fault or negligence on the part of the affected Party. In such case, no Party shall have any claim against the other for any direct, indirect or consequential loss, injury or damage.
2. If any Party is unable to perform its respective obligations under this Agreement by reason of a Force Majeure Event, then the Parties, in utmost good faith, shall enter into discussions with a view to agreeing

on such adjustments to continue the implementation of this Agreement as may be mutually acceptable and compliant with RA 8525, other relevant laws, issuances and guidelines. In the event that the Parties fail to agree on the adjustments, any Party may terminate this Agreement by providing a thirty (30) days' written notice to the other Parties.

Article XI. AMENDMENTS

Both Parties may recommend in writing any revision or amendment of any terms or conditions in this Agreement, subject to prior notification to the other Party, and shall be deemed approved when confirmed in writing. Such revision or amendment shall have the same effect as the original agreement and will form an integral part hereof. Any revision or amendment shall not prejudice the rights and obligations arising from or based on this Agreement before or up to the date of such revision or amendment.

Article XII. SETTLEMENT OF DIFFERENCES

The Parties shall exert their best efforts to properly resolve any differences or disagreements with respect to any issue that may arise in connection with this Agreement. It shall be settled through amicable means, such as but not limited to, mutual consultation and negotiation.

However, in the event that the Parties fail to settle the dispute amicably, and before any Party may proceed to litigate in court, the Parties shall first resort to Early Neutral Evaluation in accordance with the Rules on Alternative Dispute Resolution (ADR). Under RA No. 9285 or the Alternative Dispute Resolution Act of 2004, an Early Neutral Evaluation is defined as an ADR process wherein the Parties and their lawyers are brought together early in a pre-trial phase to represent summaries of their cases and receive a non-binding assessment by an experienced, neutral person, with expertise in the subject in the substance of the dispute.

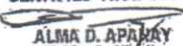
In case of failure to settle differences, the Parties shall not be precluded from submitting the dispute to the appropriate courts of the Philippines. Any cause of action for the enforcement of this MOA or any provision hereto shall be instituted only in the courts of competent jurisdiction, specifically in the appropriate courts of Pasig City, to the exclusion of all other venues.

Article XIII. DATA PRIVACY AND CONFIDENTIALITY

The processing of any gathered data and information should be in compliance with the confidentiality and privacy requirements under the said law and applicable regulations.

Sprix cannot reproduce, share, distribute data and information derived by reason of this MOA, to any third party, both local and international without the express approval of DepEd.

Article XIV. INTELLECTUAL PROPERTY

1. All Parties shall comply with Republic Act No. 8293, otherwise known as the "Intellectual Property Code of the Philippines," as amended by RA Nos. 9150, 9502, and 10372, and other applicable laws and rules governing intellectual property in the Philippines.
2. The Parties shall retain all intellectual property rights owned by them which includes but is not limited to copyrights, trademarks, tradenames, trade secrets, industrial designs, patents, and any other intellectual property that may be contained in any the tools, materials or platforms (electronic or otherwise) that each Party may use to implement the Programmes (the "Intellectual Property"). Except as provided for under Article XIV(3) below, the Parties may not use the company name, logo, trademark, service mark or tradenames of the other Party and/or its parent company, and the affiliates and subsidiaries of its parent company, as may be applicable, without the prior written approval of the such Party and/or the relevant company that owns such Intellectual Property.
3. Each Party may use the logos and knowledge products of the other Party, in relation to this Agreement, provided that such use is limited to academic and promotional materials, which include, but not limited to, logos, brochures, press releases, websites and other social media tools, provided further that the use is necessary and directly related to the accomplishment of the objectives of this Agreement. The use of the service marks of DepEd, if any, shall be in accordance with its Service Marks and Visual Identity Manual under DepEd Order No. 031, series of 2019, as may be further revised by the DepEd from time to time.

Article XV. MISCELLANEOUS

1. Except as otherwise provided herein, no Party shall have any right, power, or authority to create any obligation, express or implied, on behalf of any other Party. Nothing in this Agreement is intended to create or constitute a joint venture, partnership, agency, trust, or other association of any kind between the Parties or persons referred to herein. The employees of each Party shall remain its employees and the concerned employer shall be solely responsible for the wages, benefits, and emoluments of such employees.
2. In cases where the Programmes will require government funds, such use of public funds shall be done in accordance with Republic Act No. 9184 otherwise known as the Government Procurement Reform Act and its Implementing Rules and Regulations, Presidential Decree No. 1445 otherwise known as the "Government Auditing Code of the Philippines" and other government accounting and auditing laws, rules, and regulations.
3. The Parties shall not assign or transfer this Agreement or any of the rights or obligations granted herein without the prior written consent of the other Party, and any purported assignment made without obtaining such written consent shall be null and void.
4. This Agreement shall be governed by and construed in accordance with the laws of the Republic of the Philippines.

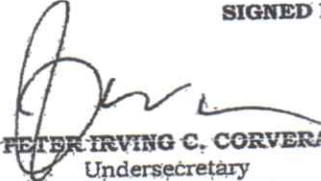

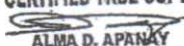

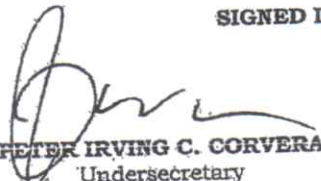
