**CONDUCT OF LEARNING FACILITATORS COURSE FOR BASIC LIFE
SUPPORT – STANDARD FIRST AID TRAINING**

To: All School Health and Nutrition Personnel
All SDO Personnel
All Others Concerned

1. In line with the Department of Education's commitment to ensuring safe, healthy, and resilient learning environments, the Schools Division of Baguio City, through the Schools Governance and Operations Division, shall conduct the **Learning Facilitators Course for Basic Life Support (BLS) and Standard First Aid Training (SFAT)** on October 5-9, 2026 at SDO Training Hall 2, SDO Baguio City, #82 Military Cutoff Rd., Baguio City.
2. The activity aims to equip selected participants with the knowledge, skills, and facilitation competencies necessary to effectively conduct, demonstrate, and support the cascading of Basic Life Support, Standard First Aid, and emergency response skills among school personnel. It further seeks to strengthen the capacity of trained personnel to serve as learning facilitators and contribute to the institutionalization of first aid and emergency preparedness practices in schools.
3. The participants, as listed in the attached list of participants, are expected to attend the entire duration of the course and actively participate in all lectures, workshops, demonstrations, facilitation exercises, simulations, and competency assessments. As learning facilitators, they are likewise expected to support the subsequent conduct of BLS-SFAT-related learning activities and the dissemination of appropriate first aid and emergency response practices within their respective schools.
4. Expenses relative to the conduct of the activity shall be charged against the **Disaster Preparedness and Response Program (DPRP) Fund**, subject to existing government accounting and auditing rules and regulations.
