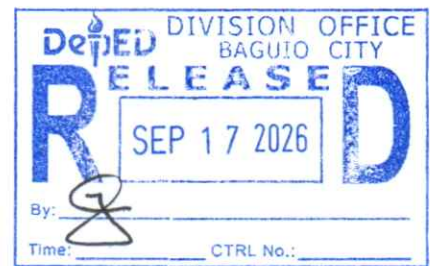

REGISTRATION FOR THE 2026 REGULAR PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)

1. The Department of Education through the Bureau of Education Assessment, and through the Curriculum Implementation Division announces the Administration of the **Regular Philippine Educational Placement Test (PEPT) in November 2026** at Manuel L. Quezon Elementary School, Baguio City. Specific date and other details shall be announced in a separate memorandum.
2. The PEPT is a nationally-administered assessment which allows learners in special circumstances to access or resume schooling and/or obtain a certificate of completion at a specific grade level within the DepEd formal education system.
3. The target registrants for the PEPT are the following:
 - a. Learners from schools without a government permit;
 - b. Learners from nonformal and informal education programs;
 - c. Learners who have incomplete or no record of formal education schooling;
 - d. Learners with back subjects;
 - e. Learners who need grade-level standards assessment; and
 - f. Learners who are overage for their grade levels.
4. Qualified registrants shall prepare and submit the following documentary requirements on or before **October 30, 2026**, during office hours at the Curriculum Implementation Division.
 - a. **For new test-takers:**
 1. Original and one (1) photocopy of birth certificate duly authenticated and issued by the Philippine Statistics Authority (formerly National Statistics Office) or by the Local Civil Registrar;
 2. Certified True Copy of the school permanent record (e.g. SF10 or Form 137) signed by the school principal/registrar/school administrator with dry seal;
 3. Certificate of attendance in intervention programs, or any proof of school (if applicable);
 4. Two (2) identical and recently taken 1x1 colored ID pictures with name tags and white background (other ID picture sizes will not be accepted; and
 5. One (1) copy of the accomplished PEPT Registration from which can be downloaded from:

b. For test retakers and PEPT passers:

1. Original and one (1) photocopy of the PEPT Certificate of Rating (COR)
2. Two (2) identical and recently taken 1x1 colored ID pictures with name tags and white background (other ID picture sizes will not be accepted, and
3. One (1) copy of the accomplished PEPT Registration Form.

5. SDO-Baguió City is allocated with **116 slots** for this PEPT. Therefore, registration and acceptance shall be on a FIRST COME, FIRST SERVED basis. **Registration shall only be accepted if the documentary requirements are complete.** Registrants who cannot be accommodated will be redirected to a nearby SDO subject to the availability of allocated test materials.

6. No walk-in policy shall be strictly implemented on the day of the test administration to ensure security, accurate evaluation and completeness of documentary requirements and orderly flow of test administration.

7. No registration fees shall be collected.

8. Other details on the administration of the test shall be released through a subsequent memorandum.
