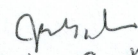

DEPARTMENT OF EDUCATION - SCHOOLS DIVISION OF BAGUIO CITY, a government agency of the Republic of the Philippines, hereinafter called "**the Entity**";
-and-

BARBIETO'S VARIETY SHOP, a corporation duly registered under the laws of the Republic of the Philippines, with principal office at Patucannay, Tayum, Abra hereinafter called "**the Supplier**";

WHEREAS, the Entity intends to procure certain goods and services, specifically through Competitive Bidding for the **PROCUREMENT FOR THE SY 2026 SCHOOL BASED FEEDING PROGRAM-SUPPLY AND DELIVERY OF NUTRITIOUS FOOD PACKS-2ND POSTING**;

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND

WHEREAS, the Department of Education – Schools Division of Baguio City included the project, **PROCUREMENT FOR THE SY 2026 SCHOOL BASED FEEDING PROGRAM-SUPPLY AND DELIVERY OF NUTRITIOUS FOOD PACKS-2nd Posting** in its Approved Annual Procurement Plan (APP) with an Approved Budget for the Contract (ABC) amounting to **Eight Million One Hundred Thirty Seven Thousand Five Hundred Seventy Four Pesos (PhP 8, 137, 574.00)**;

WHEREAS, Rule IV Section 26.1 (f) of the IRR of R.A. 12009, otherwise known as The New Government Procurement Act, provides for Competitive Bidding as one of the modes of procurement consistent with the Fit-for-Purpose procurement;

WHEREAS, in reference to BAC Resolution No. 142. Series of 2026, the Bids and Awards Committee declared the bid of **BARBIETO'S VARIETY SHOP** as the **Single Lowest Calculated Bid (SLCB)** and subjected its bid for post qualification to ascertain the bidder's compliance as to legal, technical and financial requirements of the bid;

WHEREAS, post qualification was conducted by the Bids and Awards Committee and the program owner and based on the report submitted, **BARBIETO'S VARIETY SHOP** was found legally, technically and financially compliant for the project, thus its bid was found responsive;

WHEREAS, in reference to the Post Qualification Evaluation Report submitted, the Bids and Awards Committee found merit to the recommendation stated in the report submitted, thus, declared the bid of **BARBIETO'S VARIETY SHOP** as the **Single Calculated and Responsive Bid (SCRB)**;

WHEREAS, Section 42 of the IRR of R.A. 12009 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative;
